The JINK platform has introduced a token economy to provide rewards to both content producers and consumers. This model will have a huge impact on the journal market by providing benefits to everyone.

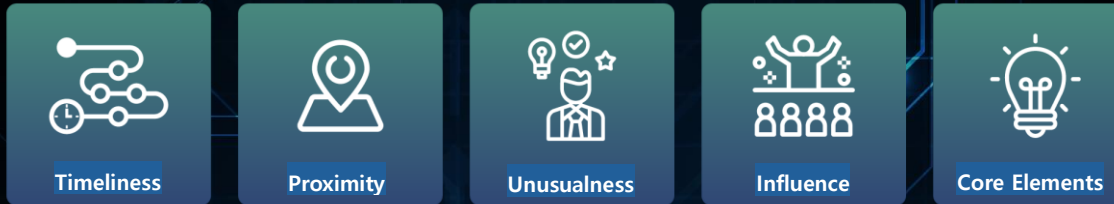
JSET token

The JINK platform has issued its own token, JSET, with the goal of platform growth and scalability to shift the paradigm for existing media. This project seeks to present an alternative to the inequality problem within the developing media environment and platform economy. Through the introduction of the JINK platform, we aim to solve the problem by providing rewards to content producers and consumers, thereby strengthening the role of journalism and presenting a new paradigm in the media market.

1. Trust in Journalism

1.1. Core Values of the News Platform

The value of news mainly consists of the following elements:



[Elements of News Value]

Timeliness

News must be relevant to the present, immediate and timely. In other words, when news is out of date, its value drops significantly.

Proximity

News can only attract attention when it is closely related to the individual. Starting with my family, neighbors, and community, interest is gradually expanding regionally, nationally, and globally.

Unusualness

Outstanding and unique events are more likely to make the news. This is because curiosity is stimulated by new things and unusual events.

Influence

News has a huge impact on people. Therefore, news that directly affects people's lives has greater value.

Core Elements

News must contain essential elements to maintain its value. Key claims and supporting evidence are essential, as without core content the value of the article is greatly reduced.

1.2. Resistance to Censorship

Censorship is a system through which public authorities inspect speech and publications. In fact, the press acts as a support for freedom, but censorship serves to limit that freedom. In other words, censorship suppresses freedom of discussion and information and poses a threat to future stability. This censorship can take many forms, including market power, political influence, and media ownership.

The emergence of IT platforms is changing the way we consume news. In these environments, technological methods to resist censorship are needed. In particular, blockchain technology can serve as a tool to resist censorship because it can increase the credibility of news by distributing information and preventing its alteration.

The JINK platform is a decentralized network news delivery system free from content censorship and is accessible to anyone around the world. This ensures the reliability and freedom of news dissemination.

2. Journalism and Blockchain

2.1. Transparency and Trust

Blockchain technology provides transparency and reliability through a distributed ledger system. In the field of journalism, where the accuracy and reliability of information are paramount, blockchain ensures data integrity by verifying and verifying transactions and data changes.

2.2. Decentralization and Verification Process

This interconnectivity allows blockchain technology to be utilized in the field of journalism.

3. JINK Platform Vision

3.1. JINK platform role

3.1.1. Diversity and Inclusion

Unlike traditional journalism, which provides curated content from a small number of individuals, the ONP platform increases diversity by encouraging participation from individuals with diverse backgrounds and expertise.

3.1.2. Cost Savings and Efficiency

The ONP platform provides cost savings and efficiency in providing a variety of content. Traditional journalism incurs significant costs in hiring professional writers and reporters, but this platform, where anyone can contribute articles, allows for resource sharing and cost savings.

The JINK platform will establish itself as a fair and transparent news platform to provide users with a space for sharing information and forming sound opinions. Above all, it defines users' activities as 'labor' and encourages fair rewards through evaluation of their participation.

4. JINK Platform Purpose

The JINK platform aims to provide the following services to members:

- Curated news and commentary
- Provide quality answers to personalized questions (expert group)
- Rewards for community activities
- Earn points based on activities
- Points convertible to Korean Won (1 JT = 1 Won)
- Referral system for recommending other members
- Equivalent reward system for recommended member activities
- Uniform reward system for all content provided on the platform

4.1. Principle of the JINK Platform

The first principle is that anyone can write and distribute articles with acknowledgment and reward of copyright. In addition, readers' actions on the platform, such as reading articles and writing, are considered 'labor' and are rewarded accordingly.

The second principle is that all content on the JINK platform, including online store operations, follows the same approach as the first principle.

The third principle promotes community participation among platform members and fosters healthy media cultural discourse. By listening to opposing views through expert voices, we build diverse perspectives and positive influence within our members and communities.

The JINK platform is structured as a sharing economy system to benefit the wider population. Unlike traditional platforms that primarily benefit from user participation and activity, JINK rewards are based on joint efforts and provide higher rewards for joint contributions. Conversely, when multiple users contribute but individual efforts are insignificant, rewards are reduced to ensure fairness and encourage broader participation.

4.2. Ethics of the JINK Platform

The JINK platform prioritizes expert diagnosis and focuses on user reward for fair and transparent news distribution. We aim to overcome the limitations of traditional media by shifting the platform's economic paradigm to sharing economic benefits with users and returning media power to the public through advertising-independent journalism.

4.3. Activities and Safety Measures

The platform's operating policy ensures simultaneous revenue sharing between consumers, content providers and the platform itself. Starting as a news platform, we are expanding into various business areas and striving to become a platform where all users share benefits.

To realize this, JINK is utilizing a new paradigm and token economy, with JSET (Journal Sharing Economy Token) serving as the platform's virtual asset. The platform also implements the following safety measures: We prevent abuse of our services by not compensating for repeated views of the same article.

4.4. Platform Influence

JINK's main goal is to attract a large user base and promote healthy opinion formation to shape social system policies. It operates as a sharing economy system, rewarding those who contribute value to the free market system.

The platform is based on the principle of fairness, allowing anyone to write news and create an environment for discussion. It represents a paradigm shift in journalism economics, where reader behavior can influence the value of content and contribute to expanding the user base.

5. Platform Usability

5.1. Current Status of Journalism

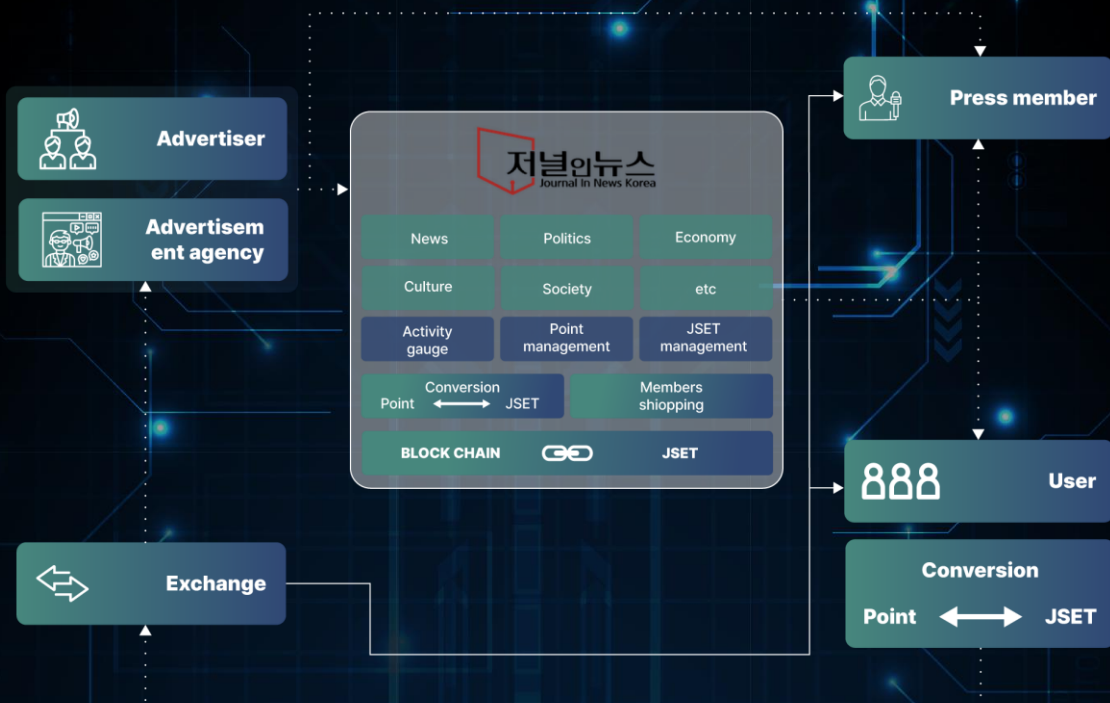

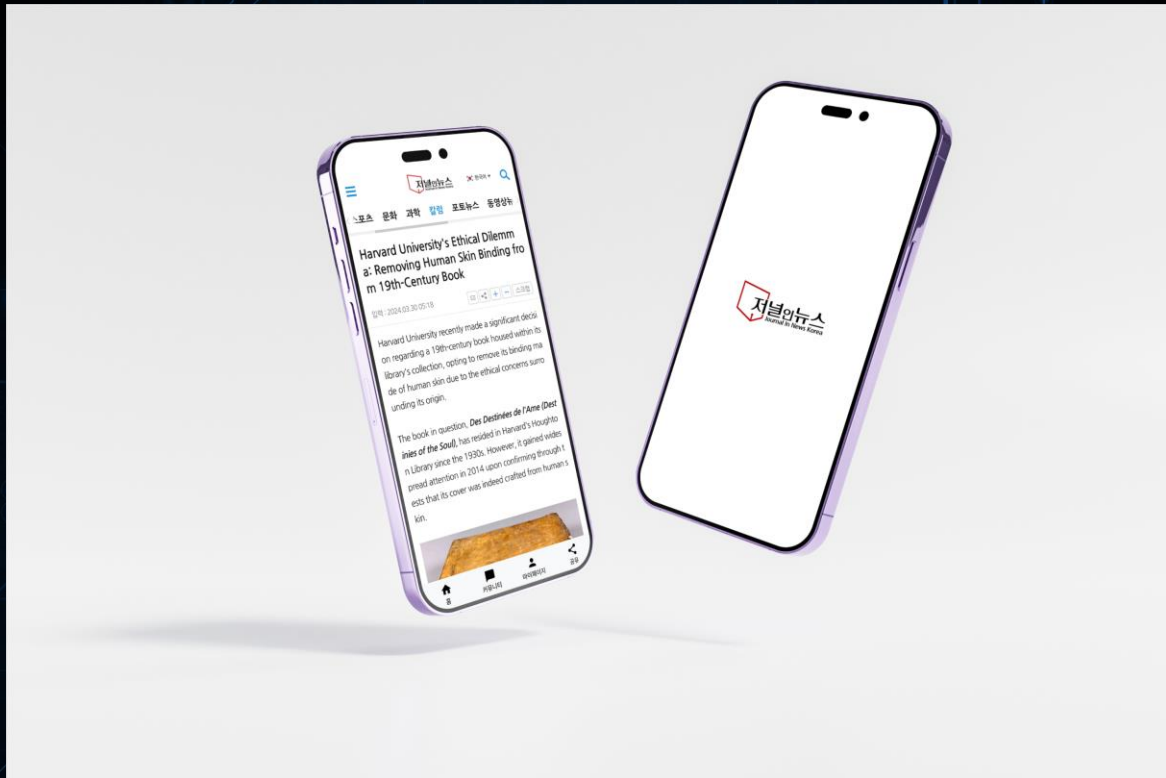

JINK App/Web



JINK (Journal In News Korea) is the world's first open news platform where anyone can write and share news articles. Readers are free to rate articles and share their opinions by leaving comments. Artificial intelligence-based algorithms provide customized news tailored to users' interests. JINK seeks to prevent fake news based on transparency and reliability. The goal is to provide a broader perspective through news from various perspectives.

6. Community Structure

Introduction

Modern people pursue diverse careers and unique lifestyles. People often seek to connect and empathize with others by sharing their way of life, which is facilitated by various social media platforms.

Recent Communication Problems

However, lifestyle depictions on social media tend to be overly idealized, leading to unrealistic comparisons and feelings of social isolation. This phenomenon affects not only youth but also adults, causing serious social issues such as rising divorce rates.

Need for Improvement

To solve these problems, a social communication system that conveys and comforts based on facts is needed, which provides an alternative to the unconscious violence often committed in communities, media, SNS, etc.

6.1. Community Formation

- Similar to browsing regular news, the community covers various fields such as politics, society, economy and culture.
- Posts in each field must be based on facts and permanently shared through blockchain technology to ensure accountability.
- Members support authors by sponsoring or sharing, and authors receive more exposure and reward when community posts are adopted as news articles.
- Introducing community communication into mainstream news can increase author's visibility and lead to a variety of journalistic positions within the company.

6.2. Media Formation

The media is made up of professional editors from a variety of fields, whose job is to rigorously select and organize articles created in the community in relevant fields. Posts that become news in the community are weighted according to the reward policy.



Reporters promoted to interns receive 1.2 times the reward, and regular reporters receive 1.4 times the reward. Professional reporters receive 1.6 times the reward, senior reporters receive 1.8 times the reward, and on-call journalists receive twice the reward.

In addition, the exposure ranking for reporters at various levels is somewhat determined. Basically, articles by intern reporters cannot occupy the highest positions due to the organized order for top exposure by on-call reporters. However, editors have the authority to prioritize articles by intern reporters for maximum exposure.

6.2.1. Journalist (W2E: Write to Earning)



- Reporters are rated based on the quality of their articles and level of activity. (Intern, full-time, professional, senior, on-call journalist)
- A reporter's rating is related to exposure after writing an article.
- Readers receive points when they read articles.
- Journalists pay commissions for advertisement and advertorials with JSET tokens.
- After listing, POINTs are exchanged for our coins and sold through the exchange.
- For advertising articles, a certain amount of JSET tokens must be paid to the platform for broadcasting.

6.2.2. Advertisers and Media

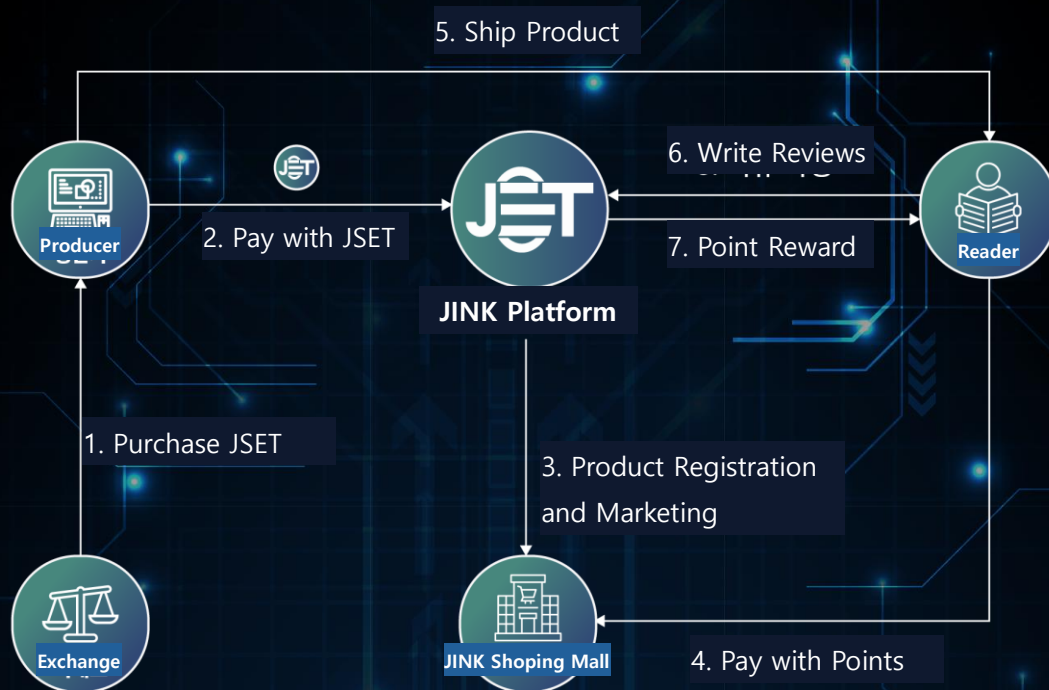
- Advertisers post banner ads for fixed token payments.
- For affiliate advertising, tokens must also be paid to the platform.
- For advertising articles, advertisers pay tokens to reporters and reporters pay tokens to the platform.
- When an overseas platform opens, advertising articles will be reproduced and aired.
- We carry out continuous online advertising through advertising media partnerships.

6.2.3. Reader (R2E : Read to Earning)



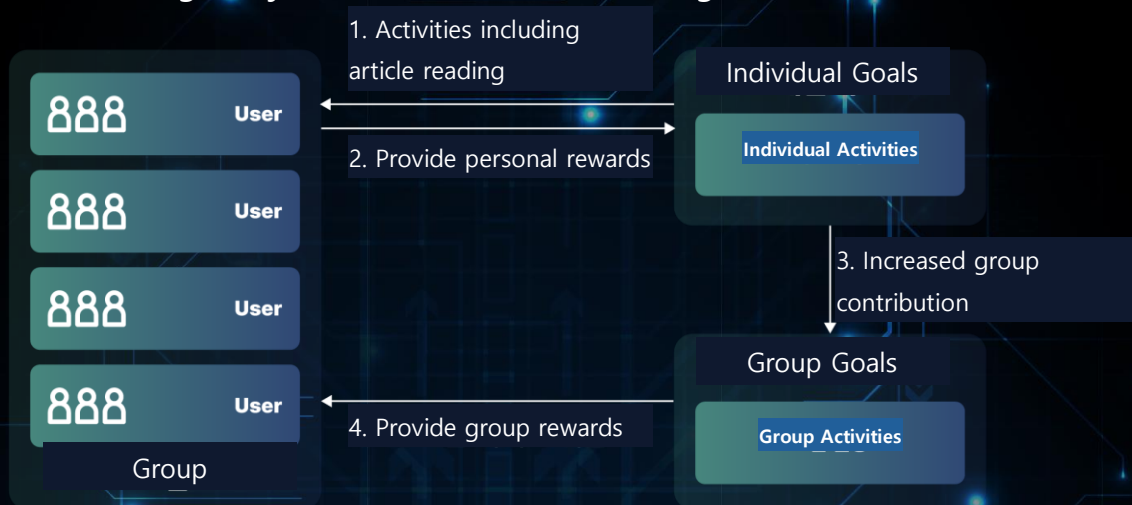
- Received rewards for platform activities.
- Accumulated points can be exchanged for tokens.
- Accumulated points can be used at our shopping mall.
- Accumulated points can be exchanged for tokens and sold through exchanges.
- Provides greater rewards based on referrals and activity level.

6.2.4. Shopping Mall (S2E : Search to Earning)



- Producers pay a prescribed amount of tokens to the platform to enter the shopping mall. (Protection against consumer risks as collateral for price increases).
- Use JSET platform payment to increase sales and provide advertising or exposure.
- Diversify product exposure and sales to global customers for global expansion.
- Maximize purchasing power through independent use of earned reward points.
- Increase credibility as readers write comments and share their experiences.

6.2.5. Achieving Daily Goal (G2E : Goal to Earning)



- When you achieve your daily goal, you will receive all the benefits shared by the group.
- Fair distribution is achieved according to activity level.

(The profits gained by the sharing group can be taken in proportion to the amount of activity.)

- One-year goal: \$1 million

Depending on the activity of your users and the groups they share with, you could earn as much as \$1 million per year.

- Simple daily goals

If you are busy, you can meet your daily goal by reading just 20 articles.

6.3. Conclusion

Overall, the JINK platform not only creates a transparent and rewarding ecosystem for journalists, advertisers, readers and shoppers, but also enables continuous development based on a token economy that enables a virtuous cycle.

7. Metaverse Structure

With the advent of the world called 'Metaverse,' a new area called virtual reality is opening up. This virtual space is free from the constraints of time and space, allowing participants to move freely and providing an experience similar to reality. We will enable media activities in this virtual reality. We plan to establish media outlets on various metaverse platforms and create a virtual space for media activities. To this end, we plan to build a virtual newsroom and press conference hall.



7.1. Metaverse Media

We are building a media outlet to operate in a virtual world. Media companies select a logo and a character called Journal in News and then provide resources necessary for media activities.

7.2. Recruitment of Virtual Reporters

We will hire journalists to work in the virtual world, following the same approach as for our platform. They will be responsible for conducting incident reports, conducting interviews and writing reports in the virtual world.

7.3. News Production

We plan to produce a variety of virtual news on a variety of topics within the metaverse. This includes reporting on events, issues, economic and technological trends occurring in the virtual world.

7.4. virtual Events and Conferences

We will organize virtual events and conferences within the metaverse to interact with the public. Media outlets will cover these events and provide coverage to relay them to the real world.

7.5. Improving Training and User Experience

Media activities within the metaverse allow users to experience a variety of coverage. Through this, we plan to provide journalist training and various classes to foster competent journalists.

7.6. Advocating Ethics and Development

Media activities within the metaverse maintain journalistic integrity and fact-based reporting. In addition, we will continue to develop by respecting diverse opinions and reflecting user feedback. This systematic media system ensures effective operation within the metaverse and provides the same reward system as the JINK platform, creating diverse opportunities and sustainable innovation.

8. Ecosystem Structure

The JINK platform aims to build a healthy ecosystem where content creators and subscribers collaborate. This concept goes beyond the media's traditional dependence on advertising and paves the way for innovative solutions in the fields of media, advertising and e-commerce.



8.1. Ecosystem Participants

Content Producer

Anyone can contribute articles or other content. Content selected by a group of experts provides higher rewards compared to regular contributions. Producing textual perspectives on current events is very meaningful. This is because news stored and distributed through blockchain technology is maintained indefinitely. Producing news content is particularly difficult and expensive because it requires fact-checking and reporting. However, articles written by experts are easier to prove with evidence and rich data that they are high-quality content.

Platform provider (JINK)

The platform promotes the creation and consumption of high-quality content and encourages active participation. Content recommended and improved by users increases quality. The platform incentivizes user activity by rewarding it with 'labor.'

■ Readers and Curators

Readers consume high-quality news content and earn money. They also engage in activities such as 'recommendations and likes.' The platform rewards these actions with points, which can be converted into tokens on the platform or exchanged on exchange platforms depending on the market price.

■ Advertiser

Advertisers can reach trusted audiences through ads on the platform. Ads are integrated with professional articles and community content. For example, medical-related articles may include hospital advertisements, and health-related advertisements may be placed alongside health articles. Advertisers can also reward professional journalists with JSET tokens for publishing promotional articles.

■ Other Content Providers

Partnerships generate additional revenue by providing additional content to users. Various content partnerships promote the activation of JSET tokens. There are many institutional mechanisms on the platform to maximize the benefits of users.

■ Shopping Mall

All companies entering the shopping mall must use JSET tokens on the platform. This can be said to be the minimum guarantee system to safely supply products to consumers. In addition, shopping malls reward users just for searching for products, and this reward system is implemented on the platform.

■ JSET Token

Points can be exchanged for JSET tokens on the platform, and the exchange rate is the current market price on the virtual asset exchange. JSET tokens were issued as 'BEP-20' considering the stability and scalability of the global platform. This means that it serves as the primary payment method using Binance standards on the platform.

9. Evaluation and Rewards

9.1. Activity evaluation and rewards

The platform rewards points for every user activity. In addition, rewards are provided for contributing activities to activate the platform, such as providing interesting materials, inviting friends, participating in tournaments and cheering for the team. In addition, participants are rewarded with points when participating in various platform events and completing missions.

9.1.1. evaluation

Platform evaluation is automatically determined by the system. To evaluate user's platform, we check activities such as daily activity, recommended activity, activity log, and content creation.

9.1.2. Reward

The platform rewards community activities, content creation, social media promotion, article reading, and other activities. Rewards for your own activities are automatically accumulated, while rewards for shared members are not yet confirmed. It will be based on user activity after midnight, depending on each country's time zone.

Reward is based on these comprehensive activities.

Evaluation based on user activity history

The platform evaluates and records user activity. This includes creating, consuming, recommending, sharing, and commenting on content. The value of article content is distributed to creators and consumers by considering recommendations, shares, and comments.

Evaluate article content

The value of content is determined by the number of creators and consumers. The value of content is constantly changing, and the system provides clear calculations to avoid user confusion. In addition, all content values are normalized to provide appropriate values.

Token Usage Rate

Regular rewards are given based on an evaluation system. Rewards are provided in real time, and special rewards may be provided on a weekly, monthly, quarterly or annual basis.

Rewards are distributed differentially according to user value and level. Tokens received as rewards can be used to purchase various content within the platform, and these transactions are carried out through the platform's own wallet.

10. Platform Vitalization Strategy

10.1. Vitalization Ecosystem

We plan to establish and implement a vitalization strategy centered on an information portal system, search and recommendation system, blockchain infrastructure and evaluation system, and blockchain P2P transaction service for safe transactions, for a stable ecosystem operation.



Stage 1: Strengthen News Service

- Develop a broadcasting system for direct news transmission
- Develop a search and classification system for convenient information access
- Develop a sharing system, such as the social media service for users and the community service for users to share information

Stage 2: Provide High-Quality Information and Develop Safe Transaction System

- Develop a blockchain-based information service for safe transactions
- Develop a personalized content recommendation service system based on user preference analysis
- Comment and review pages based on expert analysis of news information

Stage 3: Expand Global Market

- Develop a category-based specialized news platform to expand the range of news application
- Evaluation and reward system based on user behavior information
- Provide multilingual services (Chinese, English, etc.) and translation functions for global expansion

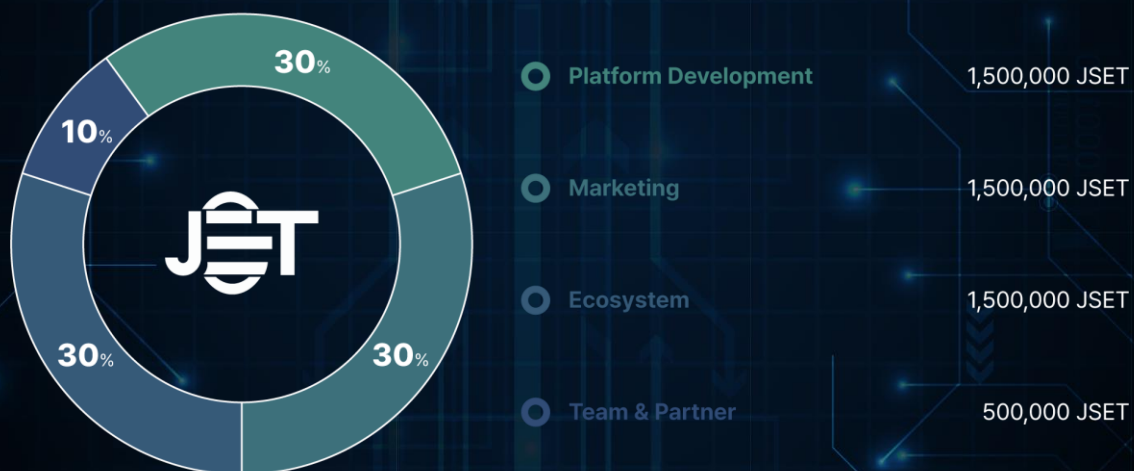
11. Token Issuing Plan

11.1. Issue of Tokens

JSET tokens utilize the BEP-20 standard token specification established by the Binance Blockchain Network, considering the stability and expandability of transactions. The NFT issuing plan and basic information are as follows.

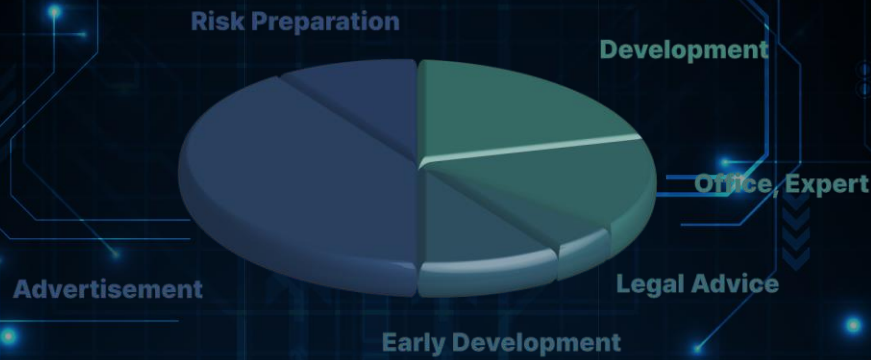

11.2. Token Distribution



As for the JSET token distribution plan, 30% will be allocated to ecosystem to support platform operation, 30% to token circulation, 10% to team/partners, 30% to platform development.

11.3. Funds Utilization Plan



Funds generated through JSET tokens will be used for research and development personnel, recruitment and operations, service and business model enhancement, DApp development, and other related purposes.

In other words, 20% of the funds will be allocated to development costs, and 15% to personnel and office operating costs, service and management staff to build services for the JSET ecosystem. In addition, 5% is allocated to legal and accounting advisory fees tailored to the legislative and practical circumstances of each country where tokens are traded.

Also, 10% will be allocated to the initial development and solution costs of the platform, 40% to marketing costs for running online and offline advertisements, and finally, 10% to company retention and risk preparation.
